Directions to the Trial Site – Strive365:

From the South, take SR41 North thru Terre Haute. Turn right (East) onto Hawthorne Ave, which is north of the traffic light at Ft Harrison and SR41. Watch for Wetnight RV's, the turn is just north of that business.

At the next 4 way stop, turn right onto 13th Street and the entrance to Strive 365 will be the second driveway on the right.

From the North, take SR63 to Terre Haute. At the SR63 and SR41 merge go north on SR41 and follow the above directions. Please note that the first traffic light you will encounter after the 63/41 merge will be the SR41 and Ft Harrison intersection.

From the East or West, find SR41 North (I70 exit will work) or SR 63 South (I74 exit) and follow the above directions.

Driving Directions: Heritage Animal Hospital North is located North of Terre Haute on Clinton Street (Lafayette Avenue in town).

Take SR41 North out of Terre Haute and turn right onto Ft Harrison, which is the first stoplight after the SR41 and SR63 split. Turn left onto Lafayette Avenue, second stoplight on Ft Harrison. Proceed North on Lafayette Avenue and Heritage Animal Hospital will be on the left approx. 3 miles.
